

SCIENTIFIC COOPERATION AGREEMENT
between the Institute for Applied Problems in Mechanics and Mathematics
of the National Academy of Sciences, Lviv, Ukraine,
and
Palermo Astronomical Observatory
of the National Institute for Astrophysics, Italy

The Institute for Applied Problems in Mechanics and Mathematics of the National Academy of Sciences of Ukraine and the Palermo Astronomical Observatory of the National Institute for Astrophysics of Italy, then the "Parties", have decided to sign the Agreement given, for the purpose of development and strengthening of scientific cooperation under the principles of partnership and mutual benefit.

Article 1

As part of the Agreement, the "Parties" agree to start and support the following activity:

1. Conducting joint fundamental and applied studies.
2. Exchange of scientists to conduct research.
3. Participation in scientific meetings, conferences, symposia which will be organized by the two or one of the "Parties".
4. Sharing the results of studies, publications and other scientific information.
5. Preparation for publications of works, which contain the results of joint studies as well as documents related to the scientific conferences and symposia.

Article 2

The parties will cooperate for the development of science and education in the spirit of European integration, in particular, initiate the enlargements of technological cooperation in the frame of the international scientific projects.

Article 3

The above directions and forms of cooperation do not limit the possibilities for expanding the cooperation between the Parties.

Article 4

The concrete conditions of financial organization and the implementation of cooperation will be specified each time by the Parties through mutual agreements.

Article 5

Parties undertake to keep the rights of intellectual property in accordance to laws of their states and international agreements.

Article 6

The final statements:

1. Changes and additions to this Agreement may be made according to mutual agreement of both Parties, in writing form.
2. The agreement becomes to be valid from the moment of signing by both parties in two copies, written in English.
3. The agreement may be terminated after the notification made three months in advance.
